# SHIA COLLEGE : BRIEF HISTORY



Shia College is one of the premier institutions spreading the light of learning and knowledge to a large number of students under the management and control of the Board of Trustees of Shia College & the School and the other connected Institutions. Following the traditions of Islam, as practised by its Prophet and his successor, the College has served all the communities without discrimination, maintaining high standards of secularism and patriotism from its very inception.

The oval shaped College Emblem carries as its motto the Hadith of the Prophet of Islam "I am the city of learning and Ali(A.S.) is its gate", a pen and a book with rays emanating from it signifying the spread of light and learning, a sword signifying a fearless struggle and war against tyranny, oppression, evil and darkness. The name of the College is at the bottom of the emblem.

The faculty members, as well as the Students and other employees have always been a true reflection of our composite culture. They have

contributed their best towards the development and progress of the College and the Nation.

It was keeping in view the best traditions of Prophet Mohammad<sup>(S.A.W.S.)</sup> who said, "To seek knowledge and learning is obligatory for all Muslim men and women", his daughter Fatima<sup>(S.A.)</sup> and his twelve successors<sup>(A.S.)</sup>, the first of whom Hazrat Ali<sup>(A.S.)</sup> said, "Let no child remain uneducated while I hold the reigns of power", that the idea of starting a degree college at Lucknow was approved by the leaders of the Shia Community in the year 1915.

A delegation met the Lieutenant Governor of the then United Provinces of Agra and Avadh to seek permission for the establishment of the College. Shia College started as a school in 1919. The classes were temporarily arranged in the premises of Asifi Imambara (Bara Imambara and Roomi Darwaza). The college rose to the status of an Intermediate College in 1922.



In the same year (1922), the foundation of the college building was laid on the land provided by the "Karbala of King Nasiruddin Haider of Oudh" on Sitapur Road. With generous donations pouring in from the masses of Shia community a spacious building for the college came into being and the classes were shifted to it in 1923. Renowned Company Martin & Bern has constructed the Building which is named after Prophet Mohammed<sup>(S.A.W.S.)</sup> as Mursal-e-Azam<sup>(S.A.W.S.)</sup> Block.

When in 1947, the University of Lucknow decided to permit the teaching of Science outside the premises of Canning College, Shia College was one of the first three Colleges of Lucknow to be found suitable for the purpose. In the same year teaching of Bachelor of Science has started.

In 1967, the college constructed new faculty blocks. The permission to start classes of Bachelor of Arts, Bachelor of Law and Bachelor of Commerce from University of Lucknow was granted in 1960, 1970 and 1972 respectively. Computer Science as a subject at B.Sc. level was introduced in 1989.

M.A. Classes in Urdu and Sociology have been started from 1995 and 1996, respectively. M.Com. (Applied Economics) and professional management course Bachelor of Business Administration (International Business) i.e. B.B.A. (I.B.) classes were started from the academic session 2005-06.

M.Sc. (Zoology) and M.Com. (Pure Commerce) classes have been started from the session 2006-07, M.A. (Journalism & Mass Communication) is running successfully from the session 2007-08.

Large library building was built in 1972. A new block for class rooms was constructed with special grant from Dr. S. Akhtar Hasan Rizvi, Hony. Secretary. In addition to this, construction of a new building

named "Hazrat Ali<sup>(A.S.)</sup> Block" completed in 2001-02. Another block on the name of Hazrat Abbas<sup>(A.S.)</sup> Block was constructed in the year 2005-06.

The construction of Basket-Ball Court and a block namely Hasnain<sup>(A.S.)</sup> Block was completed in the year 2006.

To provide quality education Shia P.G. College has advanced its infrastructure in remarkable way. Extension of **central library** and construction of double storeyed **stack room** and spacious **reading room** was done in the year 2016. Double storeyed building measuring about 19000 sq.ft. with one Seminar Hall & 12 Classrooms was constructed on the name of **Imam Jafar-e-Sadiq<sup>(A.S.)</sup>** and **Imam Moosa-e-Kazim<sup>(A.S.)</sup>**. The construction of two floor building having 16 classrooms, 2 offices, 1 staff room and 1 lab for Faculty of Arts on the name of **Hazrat Imam-e-Raza<sup>(A.S.)</sup>** was completed in the year 2019. Multipurpose hall with all modern amenities was constructed in 2021 on the name of **Hazrat Abu Talib<sup>(A.S.)</sup>**. Air Conditioned and spacious Moot Court to provide opportunity to law students for mock juridical proceedings was constructed in the year 2021, college management has named it as **Hazrat Imam Ali<sup>(A.S.)</sup> Moot Court**. In the extension of facilities for the students, an state-of-the-art **Hazrat Imam Mohd Taqi<sup>(A.S.)</sup> block** having capacity of 12 classrooms, administrative offices and staff rooms has been recently completed and was inaugurated by Hon'ble Justice Vikram Nath, Judge, Supreme Court of India. Besides, a separate **Janab-e-Khadijah<sup>(S.A.)</sup>** executive board room has been constructed.

# SHIA COLLEGE : AT A GLANCE

**1. Innovation and creativity in teaching-learning :** At Shia P.G. College, the focus is not just on the conventional teaching learning methodology, but more importantly fostering innovation and creativity in every aspect of academic delivery and learning. At Shia P.G. College, classroom experience keeps on getting continuously redefined with the inputs received from various stakeholders. The faculty follows a **student-centric** procedure by creating a learning environment which allows students to think, seek and answer. We strongly believe in promoting faculty creativity and innovation without being suppressed by rigidity of a system and at the same time ensuring that certain academic parameters and standards are observed and maintained without compromise. Such an approach is essential in making the College a best in class. At Shia P.G. College **blended, collaborative and experiential** techniques of teaching-learning applied along with technology resources to ensure effective curriculum delivery.

**2. Academic Strategy :** An extensive academic calendar and review mechanism ensures that the management of curriculum is done simultaneously on individual and institutional level. Time-table is well prepared before the commencement of each semester sticking to the University stipulation for each and every subject. Preplanning of the pedagogy by concerned faculty is used for every single session by means of Lecture Plan and course schedule. Although lectures are the common teaching method, this is supported by assignments, group discussion, role playing, brain storming sessions, field work, study tours, industry visit, organising presentations and projects. Self-Study mechanisms in the form of projects and presentations are encouraged. At Shia P.G. College, our focus is to catering student diversities so detail mechanism to identify Slow, Average and Advance Learner is practiced in effective manner and remedial classes, peer tutor, student seminar and symposium, personal counselling etc. are applied in essential part of delivery process.

**3. Feedback System :** College strictly followed the process of feedback systems to revise and redesign education quality from the stakeholders. From session 2020-21 we applied online feedback from all stakeholders.

**4. Mentoring System :** We at the college truly believe that if students have placed their trust in us for their personal and professional development, it is for us to take charge of their grooming and mentoring in every perceivable area of their development. The aim of this system is Identifying strengths and weaknesses in academics and devising ways and means to help-build competency on and off campus hours. Shia P.G. College has advanced its mentoring system by applying online process on mentoring portal. Mentoring system is the one of the best practices identified on the basis of performance and result.

**5. e-content Portal :** For effective teaching pedagogy and curriculum delivery, quality notes, e-contents and study material are playing vital role, keeping this in mind Shia P.G. College has created own e-content portal on which teachers are uploading e-content in form of **PDF/PPT/VIDEO** and also upload suggested reading materials.

**6. Facilities :** Shia P.G. College is well concerned to provide world class facilities to our students so that they will become equipped with modern technology and quality curriculum for better progression and placement.

**Library:** Central Library of the college is known as "**Khateeb-e-Akbar Maulana Mirza Mohd. Athar Library**" which is well-equipped and efficiently maintained library with **KOHA Library Automation System**. With the large number of manual books, e-library system through inflibnet and N-LIST has added new flavour for the students with the help of e-library they can avail the facility of thousands of e-books and e-journals. Library has its own website so that students can avail the remote facilities while they are away from the campus.

**Smart Classrooms:** The college has 10 smart classrooms equipped with all modern technological devices. Apart from this every department essentially have minimum 1 ICT enabled classroom, from which audio-visual experience can be provided in the class.

**Wi-Fi Campus:** Modern technology in form of smartclass, ICT, e-library etc. effectively function at Shia P.G. College because we are well aware to provide high speed internet facility. Now Shia P.G. College has 100 mbps speed connection on fiber optical leased line.



**Full CCTV Coverage:** The entire campus of Shia P.G. College is under the surveillance of CCTV in order to develop security of students. Campus has full proof system of monitoring and recording through these cameras which are placed at fixed junctions.

**Laboratories:** The laboratories in the campus are well-equipped with the latest instruments and apparatuses which are essential for proper scientific education.

**Museums :** The Zoology, Botany and Anthropology Departments have separate museum with rare and valuable collection of animals and plants collected from various parts of the country in the annual excursions undertaken by the staff and students of the College.

**Botanical Garden :** College has one Botanical Garden under the supervision of Botany department, where rare species of plants, medical plants and other sessional plants have grown .

**Computer Centre :** The College has a Computer Centre with labs equipped with modern and updated computer systems, wi-fi connectivity and electronics laboratory.

**Sports and Games :** Since its inception College has been striving for academic excellence, and at the same time sponsoring varieties of activity that would contribute to the wholesome development of personality and promote health among students. Sports and games are one such area promoted by the college with an intention of ensuring physical, mental and emotional health of the student community. College has well defined sports policy with excellent infrastructure for outdoor and indoor sports such as **King Naseeruddin Haider Cricket Stadium** with natural turf Pitch and Pavilion, PVC flooring Badminton Court, Basket Ball Court etc. College organises inter collegiate cricket tournament and inter faculty sports meet with the name "**SHIAD**" every year. College Participates in all other sports meet organized by Lucknow University or any other colleges.

**Cafeteria :** Canteens and cafeterias are one of the important parts of student life where we can find most of students chatting and gossiping on different topics. It plays a vital role in removing tensions and refreshing students. The college canteen is fairly new and provides enough and delicious food at affordable rates. The cafeterias remain open on all working days. It provides all types of nutritious and hygienic eatables and beverages to cater to the students, staff and visitors.

**Health and Wellness Clinic :** Our aim and goal is to keep students physically and mentally healthy, so that they can succeed in college and life. For this very purpose college has newly constructed Health and Wellness Centre where Physiotherapy assistance, Yoga, Meditation and Aerobics are provided to the students.

**Audio Visual Studio :** College has its own well equipped sound recording lab., video editing lab and studio for television and radio software production. We have state- of-the- art Audio -video editing console, professional audio recording facility with latest software, for having the first-hand experience to our students. Our non- linear editing studio is equipped with all the latest electronic equipment and editing software such as Avid and Premier.

**Seminar Halls :** The Khateebul Iman Hall and the Saeedul Millat Hall are two big Seminar Halls/Auditorium of the College are well equipped Seminar Hall catering to the academic needs of the College.

**Moot Court :** The exercise of mootng is one of the highlights of every law curriculum. It teaches students skills quintessential for solving legal problems. With this objective in the mind College has constructed air conditioned Moot Court hall in the name of Imam Hazrat Ali(A.S.) known as "Imam Ali Moot Court".

**Data Resource Cell :** Shia College Data resource cell is developed as a facility for automation and implementing software solution. It is also preparing database for faculty, non-teaching staff and students of the college. SCDRC is a user management module for logging creation of various levels and their management. It is an online bridge between university examination centre and college students. Various schemes of Govt. of U.P. such as Manav Sampada Portal, ABACUS, Digi-Shakti etc. are operated through SCDRC. This cell is also manages college website and various portals.

**NCC and NSS :** Shia P.G. College is the only college which have all three wings i.e. Army, Naval and Air wings of N.C.C. The College has five units of NSS. In order to

give students a practical training in social service and to familiarise them with the needs and problems of the weaker sections of the society.

**Extra-Curricular Activities :** Apart from the excellent academic curriculum, the college also gives paramount importance to the extracurricular activities. College organizes cultural and intellectual activities throughout the year to provide exposure to the students in fine arts, literature, music, theatrical art, ecology and environment. College organises inter collegiate youth fest with the name of '**EXPRESSION**' every year. College Participates in all other cultural meets organized by Lucknow University or any other colleges and won a glorious number of prizes. College has literary, dramatics, art and craft, community culture, innovative and melody clubs to enrage the creative side of our students.

**Green Campus Initiative :** College has grave concern on environment issues and catastrophic climate change. We are committed to fight and reduce carbon emission in whatever way college fraternity can.

**Student Council :** Student council at Shia P. G. College is an organization which represent students at various bodies.

**Scholarship and Financial Assistance :** S.C./S.T./O.B.C./Minority students are granted scholarships by the U.P. Govt. on the recommendation of the Principal. Financial assistance is also granted by the U.P. Govt. to other deserving and poor students. Poor and deserving students are also given aid from the students Aid Fund of the College.

**Career Counselling and Job Placement Cell :** The cell provides required guidance to student in selection of their career and better job opportunities. The Career Counselling and Job-Placement Cell of Shia P.G. College, Lucknow is intended primarily to assist students in their career planning and provides information that helps the students to give a direction to their aspirations and interests.

**Alumni Association :** The college has established Alumni association with the objective of creating a network of Shia college alumni spread all the world. The alumni association is organizing alumni meets, seminars and submits to cater the common goals of the patrons of the college.

**Extension Activities :** Students are the part of society and they should be most active member of society transformation. College is well aware of this fact that students should take the social issues to areas, community and involve them to make them concern on these issues .

**Grievance Redressal Cell :** The college is committed to providing safe , secure and nurturing learning environment to the students. For this grievance redressal committee has been set up in the accordance with UGC regulations, 2012. It provides mechanism to the students for redressal of their grievances on academic and non-academic matters.

**Parent Teacher Meeting :** Parents teacher meetings are organized each year with an objective to bring the college and home together for uplifting of the students as well as institute by maintaining harmonies relationship between parents and teachers.

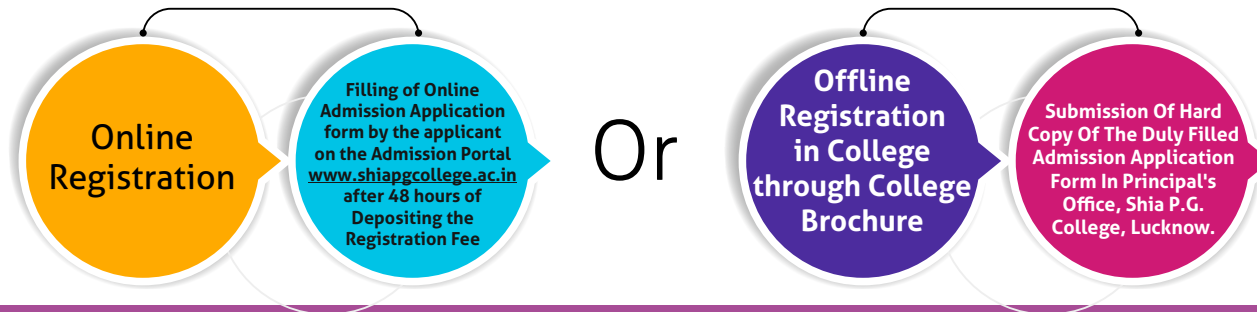

(Zoology) / M.Com. (Applied Economics) / M.Com. (Pure Commerce) and M.A. (Journalism & Mass Comm.) / LL.B. (Three Years) / LL.B. (Five Years):-
  - Marksheet / Certificate of High School & Intermediate Examination.
  - I / II / III Year Marksheets of Graduation (only for applicants' seeking admission to LL.B./P.G. courses)
  - For Address Proof, the applicant has to enclose the photocopy of one of the following documents (Aadhaar Card, Voter ID Card, Passport, Ration Card, Driving Licence, Electricity Bill, Telephone Bill).
  - Character Certificate from the Head of the Institution last attended.
  - If the applicant does not belong to U.P. then the applicant should enclose the Domicile Certificate issued by the District Magistrate of the concerned district.
  - Transfer Certificate to be submitted by the candidates for Under Graduate Courses.
  - Migration Certificate to be submitted by the candidates who have completed Graduation from the University other than Lucknow University. In case of non-availability of the Migration Certificate the candidate shall have to present the same within two weeks from the date of admission failing which the admission will automatically stand cancelled.
  - Applicants have to enclose their payment Receipt of Registration Fee.

32. The applicants who have passed their Intermediate Examination from ISC or CBSE Board and want to take admission in B.A. / B.Com./ B.Sc. (Bio.) /B.Sc. (Maths), B.B.A. (I.B.) they have to fill the total marks obtained of all the subjects and Max. Marks. in Online Admission Application Form , and not to fill best 4 or best 5 subjects mark.

#### **IMPORTANT INFORMATION**

- **If any candidate gets admission on the basis of false information/improper means or on the basis of false mark-sheet his/her admission will be treated cancelled from the beginning and legal action will be taken against him/her under IPC.**

### **GENERAL INSTRUCTIONS FOR ALL THE STUDENTS OF THE COLLEGE**

1. Fee once deposited will not be refunded in any case.
2. If an Ex.- student does not apply for the refund of Caution Money within 60 days after declaration of the result, the same will be forfeited.
3. Students are advised to note that a minimum of 75% attendance in theory and practicals (where held) is statutory binding for Arts/Science/Commerce stream for allowing them to appear at the examination. Those who fail to put in 75% attendance may not be allowed to appear at the examination.

4. Students who fail in any examination can appear at the next examination as Exempted Candidate without attending theory and practical classes according to the rules of the University of Lucknow. This facility is available only once.
5. All the students will be issued Identity Cards which they must always keep on their person and produce on demand. It is an important document which must not be lost. Duplicate Identity Cards are issued on payment of Rs. 100/- and on applying for the same along with copy of F.I.R. and an affidavit to this effect.
6. Students who wish to avail the facility of Railway Concession must fill up the prescribed form available with the clerk concerned by paying Rs.25/- and submit the duly-filled in form in the Principal's office.
7. Books with a total cost not exceeding Rs.1000/-will be issued from the Library to a student at a time. Costlier books may be issued to a student if he / she deposits the balance of the price of books as Security-Money at the respective cashier counter and obtain the receipt for the same. The amount deposited will be refundable when the student returns the book.
8. Library books will be issued for 14-days only. Thereafter, a fine of Rs.5/-day will be charged for each book for the next seven days, if the book is not returned during this period, a fine of Rs.10/-per day per book will be charged till it is returned.
9. College Uniform is compulsory for Girl students. No girl student shall be allowed to enter the college campus without proper uniform.
10. Students are advised to note down the detailed Time-Table from their respective Faculty Offices.
11. Holiday notices will be put up on the College Notice-Boards/Website as and when required.
12. The amount of fee payable shall be displayed on the Notice-Boards/Website and the applicants / students are required to pay accordingly in the form of Bank-Draft only at the time of admission.
13. Students must preserve their Original Fee-Receipts, Admit Cards; Identity Cards etc. because these
